1) Minutes of the 2021 AGM

Ulla von Ammon went through the budget in Rob Major's absence. The accountant has approved all the costs in Table A2.1. The income is approximately \$148,000 vs an expenditure of \$97,000, mainly because of the profit due to cost savings at the Tauranga conference last year so thank you to the organising committee for creating such a surplus.

Membership represents important income for the society, enabling us to support students. Membership this year is down due to the membership fees not being included in the conference registration as it is a joint conference and held later in the year than normal.

3. Proposed Budget – Rob Major (Appendix 3)

The proposed budget mostly stays the same year to year, with any surplus going to support students, and is based on the numbers from the previous year. This year we have added additional funds to new projects, such as adding vision mātauranga to our website. We welcome ideas for other ways to spend this as well. The expected surplus from this year's conference is less than in the budget which is based on last year's conference, as it will be shared with NZFSS – it is expected to be about \$20,000.

4. Auditor – Rob Major (Appendix 4)

The auditor was happy with our finances. The auditor reports will be sent around via email.

1. Applications for the 2022 NZMSS Award have been evaluated and the NZMSS Award will be presented at the NZMSS 2022 conference (no applications for the John Morton Medal were received this year).

- 2. Due to increasing costs of international travel, funds for the First Overseas Conference Travel Award were increased in 2022, and additional awards were made available in 2022 to reflect the lack of awards given out in 2021 due to Covid-19.
- 3. Applications for the last Student Research Grant round have been evaluated and this award will be presented at the NZMSS 2022 conference.
- 4. Future NZMSS Conferences We invite expressions of interest for hosting the 2023 NZMSS Conference. The 2024 conference will be a joint conference with AMSA, potentially in Tasmania, and a proposal has been put forward to hold the 2025 conference in Kaikoura/Marlborough.

Comment was made that there has not been a conference in Wellington for six years.

8) Any other business

Discussion was had on how much the conferences cost, especially for those who want to bring lots of students. The Society needs to decide whether we want expensive conferences or more "cheap and cheerful" ones. However, to get cheaper conferences we need to then rely on lots of grunt work from volunteers so that we don't have to use organisers/event planners etc. It is ultimately up to the host to not just put their hand up, but also to help with organising the conference. A significant cost is the conference organiser, but the host needs time and effort and help to put in enough to keep costs down. The food/drinks catering bill was costed up in 2021 and about half of the cost goes to this, so it is worth trying to save money here.

Note that the costs of the registration and dinner are not the real cost – we rely on sponsorship to top up the real cost. Students especially need to be subsidised – this year the early bird conference registration is \$360 + 80 for dinner for students, and \$510 + 120 for non-students. The hybrid format this year added additional costs too.

ACTION: Add conference costs as agenda item for next council meeting.

Discussion around student awards and who pays for each. The mātauranga Māori award is a big award and should be supported by the society moving forward. The society would like to thank

MUSA Environmental for initiating this award and sponsoring it last year and this year. Kura Paul-Burke moved a motion for the society to fund awards for best talk and best poster incorporating mātauranga Māori from next year onwards.

Decision to accept this moved by Conrad Pilditch, seconded by Dana Clark.

ACTION: Rob to include the mātauranga Māori student conference awards in the 2022-2023 budget.

Appendix 1 – President's Report 2021/22

It has been another busy year for NZMSS. In July 2021 we held our annual NZMSS conference, hosted by the University of Waikato and held at the University's Tauranga campus. Having a real face to face conference was very much appreciated by all who attended, as we'd had to forego our annual conference the previous year, due to the COVID-19 pandemic. Despite the threat of more lockdowns and having only a few months' notice, our hosts really pushed the waka out, resulting in a very successful conference. The conference theme was "Titiro Whakamuri, Kōkiri Whakamua – Looking Back to Look Forward". There were 475 attendees at the conference, with 6 plenaries, 249 oral presentations and 62 posters. There was a real vibe present, with people making the most of the opportunities provided to network and share the results of their research.

Over the past year or so, the Council met monthly over Zoom to discuss Society business and opportunities. We produced regular monthly updates for the members and kept them informed about a range of opportunities (e.g., scholarships, conferences and submissions) via our listserv.

We continued to support students through Student Research Grants and the First Overseas Travel Fund (FOCT). We are very pleased we can again offer support to students to attend and present at their first conference overseas, now that travel restrictions have largely been lifted. The recipients of the awards will be announced at the upcoming conference in Auckland Tamaki Makaurau.

Since our last AGM, the Society wrote submissions on several important marine issues, on behalf of our members. Topics of interest to the Society included fisheries sustainability measures, further protection for Hector's Dolphins, the wider rollout of onboard cameras, an application for a marine reserve at Waiheke Island (Hauraki Gulf), the Emissions Reduction Plan and Te Ara Paerangi – Future Pathways. The submissions can be viewed on the NZMSS website.

Financially, we are in a good position and this has enabled us to support our student members and NZMSS functions. Thanks to the efforts of last year's conference organising committee, we made a good profit which has gone back into the NZMSS accounts. Your membership fees have added to our favourable financial situation. The Treasurer's Report below details the current financial situation.

I turn now to the upcoming joint New Zealand Marine and Freshwater Sciences societies conference, being held in Auckland Tāmaki Makaurau, 21 – 24 November 2022. This year, the Auckland University of Technology is hosting our conference. I know the organising committee has been working hard to deliver a conference that will provide a forum for both the marine and freshwater science communities, as well as ensuring there will be plenty of opportunities to network and socialise. They have also produced a T-shirt which celebrates the conference theme, "Waiti Waita". I do hope to see you at the conference.

I would like to thank the 2021/22 Council members for their efforts over the past year. I have really appreciated their support and energy in helping address all the matters and issues that have come across our collective council's virtual desk.

Finally, this will be my last President's report as I will have completed my two years' "tenure" and will be stepping down from the role at the next AGM. I want to thank you all for supporting the NZMSS and leave you with this message:

"Kia nui ake tea ko ka korero ai" – "Learn more and use what you know".

Appendix 2 - Treasurer's Report (2021/2022)

Society accounts

As of 31 March 2022, there was a total of \$166,790 in the Society's accounts (Table A2.1). The Society generated a surplus of income over expenditure in 2021/2022 of \$50,964. This was primarily driven by the 2021 Tauranga conference which generated a surplus of \$35,385. Due to the continued limitations on travel we were unable to award the First Overseas Conference Travel Fund, and instead included these funds into additional Student Research Awards. Consequently, this year we awarded Student Research Awards totalling \$6000 to three students, as well as an increased number of usual student conference prizes (\$3,300). The success of the Tauranga Conference continues the councils strong financial position, which has been improving since 2015 (Figure A2.1), driven by consistent conference surpluses and lower expenditure.

We have continued to keep records in an online accounting system (Xero), maximise investment returns and reduce bank fees. Surplus from the conference account will be transferred to a term deposit following the decision-making process outlined in the financial system diagram (Appendix 3).

We will update the signatories on our Westpac accounts to include any new Officers of the Society after this AGM and will circulate and approve these minutes (by email) within one month of this meeting.

We have continued to use Simon Danson NMA Nelson Marlborough Audit Ltd to conduct our financial reviews.

Financial summary (2021/2022)

The society had an income \$148,801 over an expenditure of \$97,836 for the 2021/22-year (ex. GST) (Table A2.2). However, as no conference organiser was used for the Tauranga conference, this includes all the organisation income and expenses for the conference which were conducted through the Society's accounts. This is why these figures are significantly larger than usual rather than just representing the conference surplus and societies operating costs. Additionally, it is worth noting that the Society usually pays a GST bill of several thousand dollars each year. The Society pays GST on memberships, conference registration and sponsorship, and can claim GST on some expenditure (e.g. website), but not on others (e.g. student awards).

The Society relies on conference organisers to demonstrate financial acumen and to aim to return a surplus of c. \$10,000. Thank you to Phil Ross, Chris Battershill the conference organising committee and all the students who helped organise a run a highly successful conference. Due to their hard work the conference for returning a surplus of \$35,385 for the 2021 conference in Tauranga. Income received from sponsorship and exhibitions at the 2021 conference totalled c. \$52,000. This substantial amount demonstrates the degree to which the Society relies on sponsorship for conferences to break-even or return a surplus.

The surplus returned from this conference is the highest we have on record. Conference surpluses have varied considerably from year to year but have averaged c. \$12,000 over the past 10 years (Figure A2.2). Membership income has also varied the past 10 years with an average of c. \$9,000. Membership income is directly tied to the popularity of the conference. Consequently, with how popular the Tauranga conference was, 2021 represents the highest value for subscriptions we have on record. This membership income typically covers the annual council expenditure, and with membership not being part of the conference registration fee, it is important to register for the society if you have not.

Appendix 3 - Proposed Budget (2022/23)

To ensure that the council follows the financial system as outlined in Figure A3.1, the proposed budget:

- i. Aligns income received from the previous year's conference to expenditure in the financial year following the conference, to reflect the amount the Society can afford from known conference surplus,
- ii. Aims to keep student awards (FOCTF and Student Research award) as for last year so that students know how much is available and awards are consistent from year to year.
- iii. Recommends keeping council expenditure and ongoing website hosting and maintenance to be budgeted similar to the expenditure form last year to ensure content is up to date and that facilities work as intended,
- iv. Aims for a projected surplus of income over expenditure of c. \$9,000 (to fund student awards the following year).

The budget includes a mix of projected and actual income to reflect the amount of funds available for the 2022/23 year. Projected income includes membership subscriptions and bank interest, and actual income is from the 2021 conference. Due to the success of this conference we have been able to budget for projects (\$5000) and an additional Student Research Award. Although, as the 2022 conference is a joint conference, it will be unlikely that we will have a similar level of financial success this year.

Note that the budget has been prepared on a GST exclusive basis to reflect the amount of money available, and to be consistent with the financial summary and auditor's reports. With these recommendations in mind the council proposes the following budget for 2022/23 financial year:

Figure A3.1: NZMSS generates income in three main ways: membership fees, conference surplus and interest from society investments. Society expenditure includes core business (the costs of running the society), projects and initiatives (e.g. website redesign) and awards (e.g. First Oversees Conference Travel Awards, student conference prizes). The conference finance system uses the society investments to outlay funds such as conference deposits, which should then be returned to the society investments after the conference. However, in the event of the conference running at a loss, or any other unforeseen expenses, the society requires sufficient investments to bear those expenses.

Report on the Performance Report

We have reviewed the accompanying performance report of New Zealand Marine Sciences Society Incorporated which comprises the entity information, statement of service performance, the statement of financial performance and statement of cash flows for the year ended 31 March 2021, the statement of financial position as at 31 March 2021, and the statement of significant accounting policies and other explanatory information.

A review of the performance report in accordance with ISRE (NZ) 2400 is a limited assurance engagement. The assurance practitioner performs procedures, primarily consisting of making enquiries

of management and others within the entity, as appropriate, and applying analytical procedures, and evaluates the evidence obtained.

The procedures performed in a review are substantially less than those performed in an audit conducted in accordance with International Standards on Auditing (New Zealand). Accordingly, we do not express an audit opinion on these financial statements.
